CANCELLATION POLICY

Notification of cancellation must be made in writing and sent to AISC & MGR. Cancellation of registration will be accepted until **30 July 2005**, up to which date the total amount will be refunded less a 30% administrative charge. For cancellations made after **30 July 2005**, no refunds can be made. Cancellation of tours will be accepted until **30 July 2005**, up to which date the total amount will be refunded. For cancellations received after **30 July 2005** and up to two days before the start of the congress 50% of the expenses will be refunded.

Privacy and treatment of personal data (L. D. 196, 30/06/2003)

AISC & MGR Srl – AIM Group – with registered office in Rome, via Adelaide Ristori 38 (hereunder referred to as “The Company”), in its capacity as data controller, informs you that personal data held by the Company, either directly supplied by you, or acquired through third parties (such as, for instance, agencies, Pharmaceutical Companies or Scientific Societies) will be processed for purposes related to or resulting from the fulfilment of tasks linked to your participation in the conference, as well as for sending documents free of charge, for other meetings or initiatives both of the Company and of other AIM Group companies. Treatment of data will involve manual processing or the use of authorized electronic devices, according to a rationale strictly related to the very purpose for which they are intended and in a way as to guarantee confidentiality and safety of personal data.

Supplying your personal data is optional, but refusing to do so will bar you from participating in the conference.

The data controller may utilize other companies of the Group and/or subjects he trusts (hereunder jointly referred to as “Third Companies”) who, in their capacity as independent data controllers, may carry out technical and organizational services, such as printing, enveloping, transmission, transport and delivery of communications to customers, data processing and/or counselling in information technology.

Consent also applies to treatments performed by Third Companies, whose identity may be communicated on request and free of charge by the data Controller. With regard to the above purposes, the Company will process Your personal data such as your name, address and other personal identification elements, tax code, VAT number, banking and payment identification numbers (i.e. ABI, CAB, current account and credit card number), data on your qualification as participant and the Institution to which you belong.

Your data may be communicated to Third Companies as well as to scientific associations, publishing houses, banking and financial intermediaries and companies taking part in the conference with promotional tasks.

Specific categories of people, responsible for data processing, may have access to your personal data, to fulfil tasks entrusted with them. In particular, the Company has given its own employees and collaborators responsibility with respect to conference participants’ data processing.

Your personal data may be also accessed by subjects responsible for data processing on behalf of the Company, in order to fulfil their tasks. Presently, the Company has not yet assigned such responsibility.

Your personal data will not be disclosed.

Article 7 of the Italian Legislative Decree n. 196 of June 30th 2003 provides for some specific rights according to which you may ask for:

A confirmation of the existence of any such personal data, even if not yet recorded and their communication in an intelligible form;

B information on the source of any such personal data, on the aims and modes of processing as well as on the rationale applied if processing is carried out by means of electronic devices;

C indication of the Data Controller’s identification data and of those of any person responsible, of subjects and categories of subjects to whom your personal data may be communicated, or who may have access to them as responsible for or in charge of processing;

D cancellation, transformation into anonymous form or blocking of data processed in violation of the law, as well as updating, rectification and integration of data, if this is relevant for you.

You are entitled to oppose to your personal data processing, on legitimate grounds, albeit they may be relevant to the purposes for which they are collected, including when they may be used as advertising material for direct sales, for market surveys and for commercial communications.
